## Parental Choice Tax Credit Dashboard

The Idaho Parental Choice Tax Credit program consists of the parental choice tax credit for qualifying expenses paid in 2025 and the advance payment for estimated qualifying expenses you'll pay in 2026. Either can provide up to \$5,000 per eligible student or \$7,500 per eligible student with a disability who needs ancillary personnel. No one is guaranteed to get either. See the [My School Choice](#) website for details.

The application closes March 15, 2026. We process applications in the order we receive them.

The application below is in three parts. You can complete the application all at once or a section at a time. You can track the progress from the dashboard. You'll also receive a web message when you submit the application. You can get started by clicking **Start My Application** to start the application.

- School information (Address, start date)
- Electronic copies (scanned or photos taken with your phone are OK) of receipts for non-public school expenses. These which might include:
  - Advanced placement assessments
  - College admission assessments
  - A single curriculum that covers, at a minimum, the four core subjects
  - Industry recognized certification exams
  - Nationally standardized assessments
  - Prep courses for nationally standardized exams
  - Textbooks or other supplies for the four core subjects
  - Transportation cost to and from the nonpublic school
  - Tuition for a nonpublic school that covers, at a minimum the four core subjects of English language arts, mathematics, science, and social studies
  - Tutoring for the four core subjects



For the parental choice tax credit, you must upload electronic copies of receipts for expenses paid in 2025 for this student.

If you're awarded the advance payment we will send it as direct deposit to your bank account. You must reconcile the expenses through TAP in 2027. You must repay any money not spent on qualifying expenses, or for which you don't have proper receipts. You will get instructions on how to reconcile in TAP.
