

**SCHOOL DISTRICT NO. 58  
RESOLUTION CALLING FOR  
SUPPLEMENTAL LEVY ELECTION**

WHEREAS, in accordance with Section 33-802(3), Idaho Code, as amended, the Board of Trustees of Aberdeen School District No. 58, Bingham County, Idaho, has determined there is a need for a supplemental levy in the amount of Nine Hundred Fifty Thousand and no/100 dollars (\$950,000) per year for two (2) years, for the purpose of paying all lawful expenses of maintaining and operating the District for the fiscal year beginning July 1, 2026 and ending June 30, 2028.

NOW, THEREFORE, be it resolved by the Board of Trustees of Aberdeen School District No. 58, Bingham County, Idaho, as follows:

Section 1. That a supplemental levy election be held, and the same is hereby called to be held in Aberdeen School District no. 58, on May 19<sup>th</sup>, 2026, for the purpose of submitting to the qualified electors of the District, the question set out in the form of the ballot appearing in Section 3.

Section 2. That on May 19<sup>th</sup>, 2026, said election will be conducted by the Bingham County Elections Department pursuant to Title 34 Idaho Code.

Section 3. That the ballot will be prepared by the Clerk of the Board of Trustees and will be in substantially the following form:

**QUESTION:** “Shall the Board of Trustees of Aberdeen School District No. 58, Bingham County, State of Idaho, be authorized to levy a supplemental levy, as permitted by law in Section 33-802(3), Idaho Code, in the amount of Nine Hundred Fifty Thousand and no/100 dollars (\$950,000) per year for a period of two (2) years, commencing with the fiscal year beginning July 1, 2026 and ending June 30, 2028, for the purpose of paying all lawful expenses of maintaining and operating the schools of the district provided in the resolution of the Board of Trustees adopted on February 18<sup>th</sup>, 2026?”

The estimated average annual cost to the taxpayer on the proposed levy is a tax of \$201.78 per \$100,000 of taxable assessed value, per year, based on current conditions.

The proposed levy replaces an existing levy that will expire on June 30, 2026 and that currently costs \$201.78 per \$100,000 of taxable assessed value.

\_\_\_\_\_ IN FAVOR OF authorizing the levy in the amount of up to \$950, 000 per year for two (2) years

\_\_\_\_\_ AGAINST authorizing the levy in the amount of up to \$950,000 per year for two (2) years.

Section 4. That the Clerk of the Board of Trustees will convey to the Bingham County Elections Office the official ballot and the Notice of Election, appearing in Section 6, for publication pursuant to Idaho Code.

Section 5. That the County Commissioners will act as the canvassing board pursuant to Idaho Code and will convey the results to the Aberdeen School District Board of Trustees.

PUBLIC NOTICE IS HEREBY GIVEN according to law and requisite action by the Board of Trustees of Aberdeen School District No. 58, Bingham County, Idaho, that a special replacement supplemental levy election will be held on Tuesday, May 19<sup>th</sup>, 2026, in the Aberdeen School District No. 58, Bingham County, State of Idaho, for the purpose of submitting to the qualified electors of said District their vote at precinct polling sites open 8:00 am – 8:00 pm for the question “Shall the Board of Trustees of Aberdeen School District no. 58, Bingham County, Idaho, be authorized and empowered to levy a supplemental levy, as permitted by law, in the amount of Nine Hundred Fifty Thousand and no/100 dollars (\$950,000) per year for two (2) years, for the purpose of paying all lawful expenses of maintaining and operating the schools of the District for the fiscal year beginning July 1, 2026, and ending June 30, 2028?” Said election will be conducted pursuant to Title 34 Idaho Code.
