

**GLENN'S FERRY JOINT SCHOOL DISTRICT #192
RESOLUTION CALLING FOR
SUPPLEMENTAL LEVY ELECTION**

A RESOLUTION CALLING A SPECIAL ELECTION TO BE HELD FOR THE PURPOSE OF SUBMITTING TO THE QUALIFIED ELECTORS OF GLENN'S FERRY JOINT SCHOOL DISTRICT #192, ELMORE AND OWYEE COUNTIES IDAHO, THE PROPOSITION OF AUTHORIZING A SUPPLEMENTAL MAINTENANCE AND OPERATIONS LEVY.

WHEREAS, in accordance with Idaho Code §33-802(3), the Board of Trustees of Glenn's Ferry Joint School District #192, Elmore and Owyhee Counties, Idaho (the "District"), has determined there is a need for a supplemental levy in the amount of \$390,000 (Three Hundred Ninety Thousand Dollars), per year for two (2) years for the purpose of paying all lawful expenses of maintaining and operating the District for the fiscal years beginning July 1, 2026, and ending June 30, 2028 (the "Supplemental Levy").

NOW, THEREFORE, be it resolved by the Board of Trustees of Glenn's Ferry Joint School District #192, Elmore and Owyhee Counties, Idaho, as follows:

Section 1: That a school supplemental levy election is hereby called to be held in Glenn's Ferry Joint School District #192, Elmore and Owyhee Counties, Idaho, on Tuesday, May 19th 2026 (the "Supplemental Levy Election"), for the purpose of submitting to the qualified electors of the District, the question set out in the form of the ballot appearing in Section 5 herein.

Section 2: That pursuant to Idaho Code §34-1401, the Clerks of Elmore and Owyhee Counties, Idaho (the "County Clerk") shall administer the Supplemental Levy Election pursuant to and in accordance with Title 34, Idaho Code.

Section 3: That in compliance with Idaho Code §34-914, the clerk of the District shall notify the County Clerk that the District has called the Supplemental Levy Election by delivering to the County Clerk a copy of this resolution, including the form of official ballot appearing in Section 5 and the form of notice of the Supplemental Levy Election set forth in Section 6, for election preparation and publication pursuant to Title 34, Idaho Code. The clerk shall submit these forms to the County Clerk prior to March 13th, 2026 .

Section 4: That said Supplemental Levy Election shall be conducted as other school elections by the County Clerk in accordance with Title 34, Idaho Code.

Section 5: That the form of the official ballot will be substantially as follows:

QUESTION:

Shall the Board of Trustees of Glens Ferry Joint School District #192, Elmore & Owyhee Counties, Idaho, be authorized and empowered to levy a supplemental levy, as permitted by Idaho Code §33-802(3), in the amount of \$390,000 (Three Hundred Ninety Thousand Dollars), per year for two (2) years commencing with the fiscal year beginning July 1, 2026 and ending June 30, 2028 for the purpose of financing any lawful expenses of maintaining and operating the schools of the District; all as provided in the Resolution of the Board of Trustees of Glens Ferry Joint School District #192 adopted on March 11th, 2026.

"The estimated average annual cost to the taxpayer on the proposed levy is a tax of \$63.00 per \$100,000 of taxable assessed value, per year, based on current conditions. Currently, the District collects a supplemental levy that costs \$63.00 per \$100,000 of taxable assessed value, and the current levy will expire on June 30, 2026, so the proposed levy, if approved, produces a net increase of \$0.00 per \$100,000 based on current conditions."

NOTICE IS HEREBY GIVEN that pursuant to the laws of the State of Idaho and the Resolution of the Board of Trustees of the Glenn's Ferry Joint School District #192, Elmore and Owyhee Counties, Idaho, adopted on March 11th, 2026, a Supplemental Levy Election will be held on Tuesday, May 19th, 2026, between the hours of 8:00 a.m. and 8:00 p.m., for the purpose of voting upon the question and proposition of authorizing a levy as follows:

QUESTION:

Shall the Board of Trustees of Glenn's Ferry Joint School District #192, Elmore & Owyhee Counties, Idaho, be authorized and empowered to levy a Supplemental Levy, as permitted by Idaho Code §33-802(3), in the amount of \$390,000 (Three Hundred Ninety Thousand Dollars) per year for a period of two (2) years

commencing with the fiscal year beginning July 1st, 2026 and ending June 30th, 2028 for the purpose of financing any lawful expenses of maintaining and operating the schools of the District; all as provided in the Resolution of the Board of Trustees of Glens Ferry Joint School District #192 adopted on March 11th, 2026.

The estimated average annual cost to the taxpayer on the proposed levy is a tax of \$63.00 per \$100,000 of taxable assessed value, per year, based on current conditions. Currently, the District collects a supplemental levy that costs \$63.00 per \$100,000 of taxable assessed value, and the current levy will expire on June 30th, 2026, so the proposed levy, if approved, produces a net increase of \$0.00 per \$100,000 based on current conditions.

Said Supplemental Levy Election will be conducted pursuant to Title 34, Idaho Code.

Section 7: That the County Commissioners will act as the canvassing board pursuant to Idaho Code §34-1410 and §§34-1201 *et seq.* and the County Clerk will certify and convey the results to the District.

Section 8: That if at the election a simple majority of the qualified electors of the District authorize such levy, the Supplemental Levy shall be approved and become effective in accordance with the provisions of Idaho Code §33-802.
